We have accomplished a great deal this year, but we are just getting started. We are excited to build on our successes, forge new paths, and communicate the value PMI Metro St. Louis brings to both the Project Management Profession, and our community.

Membership - Focus on Retention and Growth

For 2019, we focused again on growth and retention of our membership and strove to reach 2000. We believe the auto-rejoin feature was instrumental for retention, but our membership itself also increased. The chapter hit 2000 members in May 2019. Membership and retention are both up. Guest memberships for our local chapter allowed us to prove our value. We used the Guest Pass program to target potential members earlier while at colleges and universities when they are starting to consider project management as a career. Our membership team provided new and returning members with information regarding the benefits of their membership.

Mentoring – Mary Tullock-Gavenda returned as our <u>Director of Mentoring</u>. She hosted 2 Speed Mentoring events in 2019, one in the spring and one in fall. They were a big success and we were able to secure partial funding through a sponsor to reduce chapter costs.

Members Services. Terry Farwell returned as our <u>Director</u> of <u>Member Services</u>. The team has continued our Member Services table, welcoming our event attendees with PMI and chapter information. We held two New Member Orientations this past year in March and October, during which the President and VP's attended and shared their roles and area information. This has been a great success, and shows our membership the value the chapter provides, as well as how they can volunteer and get involved with the chapter to be able to get the most out of being a member.

Military Liaison. Mark Hammack was our new Director as the <u>Military Liaison</u>. This role reaches out to help transitioning military and veterans looking for a project management career.

Our membership increased from 1929 on 1/1/2018 to 2002 as of 12/31/2019 with a retention increase from 79.32% to 80.98%, respectively. Great effort by the whole team!




A Look Ahead – Plan for 2020

"PMI After Hours" Networking Events: Provided 2 Networking events for members to choose from. One in Maplewood, MO and one in O'Fallon, IL. These events allow attendees the opportunity to network with colleagues from all industries in the Metro St. Louis area.

Breakfast Events: Our variety of Breakfast Meeting venues allowed members to choose from 5 different locations. They were held at Chesterfield, St. Charles, Des Peres, Fenton (Maritz), MO as well as in O'Fallon, IL.

The Professional Development Department is responsible for all training and educational opportunities where PMI Credential Holders earn >= 4 PDUs. Throughout 2019 we offered a variety of educational courses and workshops:

- PMP / CAPM Certification Exam Prep Classes (online and in-person)
- PMI-ACP Certification Exam Prep Class (online)
- PMI-PBA Certification Exam Prep Class (online)

Paul Jimenez was instrumental in helping us organize and facilitate our PMP/CAPM class that was held in the fall of 2019. He coordinated with all of the instructors and ensured the logistics were on track so that the class would be successfully delivered.

In 2019 we held 2 PDD Day Events. Two key note speakers held PDD day events in addition to speaking at our chapter meeting. Andy Kaufman held an all day workshop in the Spring and provided insight into 'Developing your Ability to Lead.' In the Fall, Kari Maribal shared with us networking tips in her book 'You Already Have the No.'



Looking toward 2020 Kathy Wren was voted by the board to complete the Vice Presidency term through 2020 when Peggy Johnson stepped down. The team looks forward to continuing to offer certification classes in 2020 as well as PDD workshops.

We will focus on:

2019 has been a good year for the Outreach Team!

Corporate Outreach

- Increased its stretch with an addition of 3 Corporate Ambassadors for corporations with a tremendous footprint in St. Louis Bayer, Center and SSM.
- Developed a monthly schedule to communicate with their organizations regarding PMI and PMIMSL events and industry news.
- Presented at Centene's Project Management Summit the impact and benefits of joining PMI and becoming involved in the local chapter. The Summit, sponsored by Centene's Enterprise PMO, had over 200 attendees from across the US.

Academic Outreach

- Hosted PMI Virtual Student Summit. The free event offered opportunities for students studyingPM or a related program to learn and network. Sessions were developed to help students build their technical skills and prepare for careers as a PM.
- Conducted a collaborative effort with St. Louis University to allow students the opportunity to ask questions to current PMs. The PMs shared their experiences while answering student questions geared towards leadership, risk, scheduling, budgets and other areas of PM.
- Reviewed final PM projects for Washington University students.

Community Outreach

- Participated in the Sea of Flags with the Greater St. Louis Honor Flight providing a hearty welcome of cheers, smiles, enthusiasm, gratitude and honor to our World War II, Vietnam, and Korean veterans on this flight. The Honor Flight recognizes veterans with a day of honor, remembrance and celebration.
- Delivered a PM Workshop to Catholic Charities of St. Louis titled "Project Management Processes and Techniques." An overview of PM and topics surveyed prior to the workshop such as the PM role, Process Groups, Gantt Charts, managing multiple projects and minimizing risk. Topics of interest the material covered were rated as Good or Excellent by 90% of the participants.
